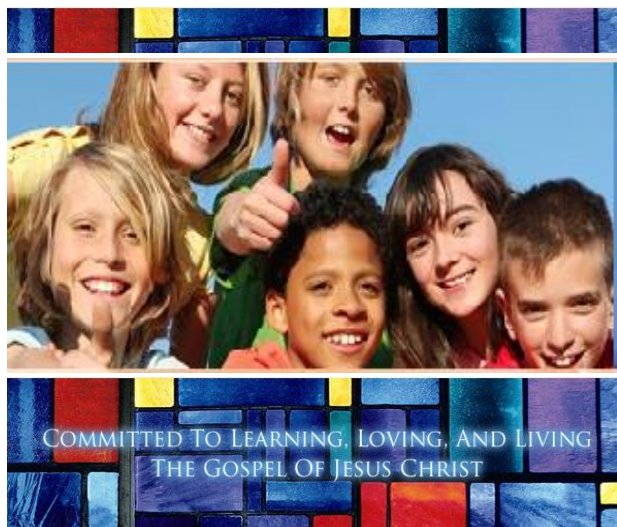


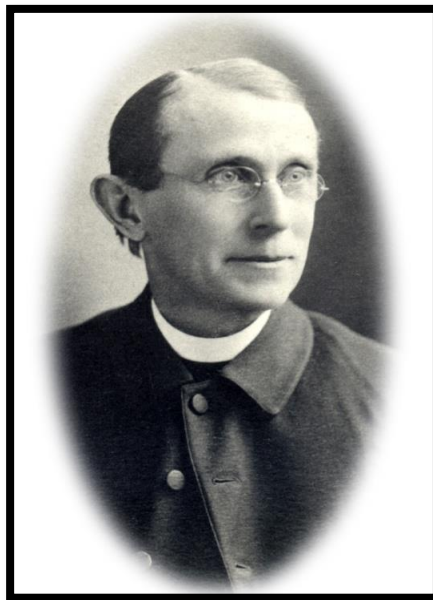
## IF YOU FIND THAT SAINT MARGARET PARISH HAS PLAYED AN INTEGRAL ROLE

**Ways to Make a Planned Gift**

**BEQUEST:**

Bequests can be included in a standard will or added to an existing will by means of a codicil. You can choose to leave a specific dollar amount or opt to bequeath a remaining portion of your estate after all other distributions have been made.

**NAME SAINT MARGARET PARISH OR SCHOOL AS A BENEFICIARY:**

- Retirement Plan or IRA
- Life Insurance
- Brokerage Account

**NAMED ENDOWMENT FUND:**

Through the Catholic Community Foundation you can establish an endowment to perpetuate support of our parish, school, or other designated beneficiaries.

**CHARITABLE REMAINDER TRUST:**

Upon the death of the donor or last surviving income beneficiary, remaining assets benefit Saint Margaret Parish.

**CHARITABLE GIFT ANNUITY:**

With charitable gift annuities, cash or securities are gifted to Saint Margaret. In return for your gift, an annuity provides a guaranteed, lifelong stream of income to you or to you and one other beneficiary, and you receive a tax deduction. The remaining balance passes on to Saint Margaret upon the death of the last beneficiary.
